Open Minutes

1. Open Minutes of the Previous Meeting

1.1 Scheduled Meeting

Scheduled Meeting – 8 December 2021

2. Te Pūkenga February 2022 Council Meeting

The members received a verbal update of the Operating model.

Action:

Place on the Agenda of the next meeting of Te Poari Akoranga – For Discussion **Ako Network (the delivery stream of the Operating model)** - noting several work streams will be ready to talk through initial key elements.

3. Quality Assurance and Academic Regulatory Framework

The members received an update of the Quality Assurance and Academic Regulatory Framework.

Insights included:

- The framework will be referred to as Te Kawa Maiororo | Te Pūkenga Academic Regulatory Framework - *'kawa' the formal customs that guide protocol on the marae, and 'maiororo' the outer earthworks of a fortified pā erected to shelter all who dwelt within from harm. If we view Te Pūkenga as the marae, then Te Kawa Mairororo provides the framework that guides all interactions and gives assurance and certainty.*
- Six working groups have been established, with memberships of each group drawn from across the network, including representatives from WBL (Work Based Learning), TITOs (Transitional Industry Training Organisations) and WDCs (Workforce Development Councils).
 1. Enrolment
 2. Recognition of Prior Learning (formal and informal)

3. Learning and Teaching (includes postgraduate and research/rangahau Māori)
 4. Assessment
 5. Learner Integrity, and
 6. Concerns, Complaints and Appeals
- A Graduation Working Group has also been established and will focus on awards and graduation. This group will begin work in March 2022.
 - The Enrolment Working Group has paused until March 2022 to enable members of this group to prioritise enrolments and implementation of Vaccination Processes and Policies as they prepare to receive learners at their respective sITPs, TITOs.
 - Completion and approval of Te Kawa Maiororo and Te Arotaki by July 2022.
 - Implementation of Frameworks – latter part of 2022.

Discussion included:

- Timelines for engagement and consultation with the network in relation to the work undertaken in Te Kawa Maiororo | Te Pūkenga Academic Regulatory Framework.
- Progressing work in Te Arotaki | Te Pūkenga Quality Assurance Framework and the development of Te Pūkenga quality practices and approaches to self-assessment, moderation, and stakeholder voice.
- Development of templates for policies and procedures by the Steering group for use by the Working groups.
- WBL engagement and membership across the working groups to ensure reflection and incorporation of work based learning context in the Frameworks.
- Working with Te Poari Akoranga and ngā ohu whakahaere in relation to an engagement strategy to identify all relevant groups, for consultation.
- Establishing and maintaining connections across Te Pūkenga portfolios, such as Te Pae Tawhiti to align work with mahi that is already being done in other areas.
- Transition timelines.
- Learner communications.
- Network communications.
- Oversight and alignment that mahi is not being duplicated by all the different Working groups and within the Frameworks.

Te Poari Akoranga acknowledged the commitment and undertaking of the work by the members of the Steering and Working Groups throughout the development stages of the Te Pūkenga Quality Assurance and Academic Regulatory Framework.

4. Kaikōkiri Director Approvals | Delivery and Academic, Te Pūkenga

The Chair welcomed and introduced the Kaikōkiri Director Approvals to Te Poari Akoranga. The Kaikōkiri Director Approvals gave a mihi to the members and provided an overview of her role.
