Request under the Official Information Act 1982

Thank you for your emailed letter received on 11 November 2025, requesting information from Unitec | New Zealand Institute of Skills and Technology (Unitec).

You requested the following information regarding ākonga (student) applications to Unitec:

I seek data for the most recent full academic year available (e.g., for the 2024 academic year, or if 2025 is complete, then 2025).

The information I am requesting is:

1. *The total number of domestic and international student applications that were declined by Unitec for the specified academic year.*
2. *A detailed breakdown of the reasons for these application declines.*

To be specific, I ask that the breakdown of reasons includes, but is not limited to, the following categories:

- a) *Academic entry requirements not met (e.g., insufficient grades, missing qualifications).*
- b) *English language proficiency requirements not met.*
- c) *Programme was full / no available places (this is to be done on a program by program basis).*
- d) *Applicant did not meet specific programme requirements (e.g., portfolio not accepted, interview unsuccessful).*
- e) *Incomplete application or failure to supply required documentation by the deadline.*
- f) *Failure to meet character or fitness for practice requirements (e.g., for nursing, social work).*
- g) *Financial reasons (e.g., for international students, evidence of funds not provided).*
- h) *Previous academic misconduct or disciplinary issues.*
- i) *Any other reasons, which should be specified.*

This letter provides a formal decision on your request under the Official Information Act 1982 (OIA).

The information you have requested is attached at **Appendix One**.
